2012 Membership Annual Dues:

Includes golf for any ONE designated person. Dues are billed annually and may be paid in advance or monthly installments are accepted as a convenience to our members.

Member: *A registered owner of stock in the corporation, his/her spouse, or unmarried children to age 23 who are living at home, or enrolled in college or vocational school. (Children ages 6 through 12 years must play with an adult.)*

Associate Member: *A nonvoting member in the corporation, his/her spouse, or unmarried children to age 23 who are living at home, or enrolled in college or vocational school. (Children ages 6 through 12 years must play with an adult.)*

Junior Member: *A nonvoting member between the ages of 24 and 35, his/her spouse, or unmarried children to age 18.*

Members Guest: *Guest must play with member and must notify Pro Shop when making tee time.*

Membership at Avondale-on Hayden Golf Club

Avondale-on-Hayden Golf Club is a member-owned semi-private Club dedicated to offering its members and guests excellent golf within reasonable financial guidelines. The Club will maintain the golf course and other facilities to the highest standards and provide a quality staff to create a friendly atmosphere for all to enjoy. Accomplishment of these goals will require the Club to maintain a satisfying work and membership environment as well as a strong financial condition.

Dues

Once dues are approved by the Board and levied against the membership on January 1st of the upcoming year, the member has the responsibility to either pay the dues in full or arrange to have the dues broken down into 12 monthly installments. Any account not paid in full by the end of the month following statement is delinquent. A service charge at the annual rate of 18% (which is computed as a periodic charge of 1.5% per month) will be added to all accounts remaining delinquent past 30 days. From the months of April through September there will be a \$30.00 food minimum charged to each account. Any food and beverage (alcoholic beverages included) purchased under your Avondale account will be applied towards this food minimum. The annual dues & passes paid by a member, associate member or JR. member shall entitle him or her to Club privileges for himself/herself, the spouse, and minor, unmarried children; such privileges available under the regulations, rules and fees adopted and published by the Board of Directors. A delinquency in the payment of dues may result in the suspension of both individual and family membership privileges.

Termination of Membership

A member, in good account standing, who no longer desires the privileges of membership may surrender his or her certificate in exchange for being relieved of liability to pay all **future** dues and assessments arising out of membership. The member is **not relieved** of liability to pay **current annual** dues and assessments that have been levied against the member on January 1st of the current year. A surrender fee will be charged based on the member's contract with the club.

Sale of Stock

The Club may, from time to time, provide a list of members, in good account standing, wishing to sell their membership in the Club. This list is published as a service to members and prospective buyers and to facilitate transfer of ownership. The Club, as transfer agent, may collect funds for the purchase price of the stock and a \$400.00** transfer fee and reimburse the seller accordingly. ****all fees are subject to sales tax.**
